## 1. Scope of Work:

- 1.1 Client hereby contracts with WBAC for scheduled inspection(s) of expansion joint systems over a period of time as mutually agreed upon by Client and WBAC, as set forth on Schedule 1. Scheduled inspection(s) shall be limited to the expansion joints specifically identified on the attached Schedule 1 (collectively, the "Systems").
- 1.2 The scope of services covered by this Agreement is set forth on the attached Schedule 1.

## 2. Coordination:

- 2.1 WBAC shall be provided at least four (4) weeks' notice prior to the first date of inspection and reserves the right to reschedule within a reasonable timeframe for proper scheduling of its resources.
- 2.2 Cleaning/clearing of Systems by WBAC either before or after inspection is not included. Client shall ensure that the Systems are cleaned/cleared immediately prior to each inspection. If the Systems are not cleaned/cleared sufficiently to allow WBAC to perform the inspection, Client shall bear any delay costs and other fees, costs and expenses incurred by WBAC, including, without limitation, time costs, remobilization costs, additional travel costs, and any other costs arising from such issues.
- 2.3 Inspections shall occur during normal work days and between the time of 7:00 am and 5:30 pm. An important part of each inspection is to verify actual conditions the Systems are exposed to, including but not limited to, vehicular type and speed, snow removal equipment, exposure to atmospheric effects such as wind and ultraviolet rays, and general adjacent conditions. Special arrangements for overtime or working hours other than those described herein shall be negotiated and fees adjusted accordingly, but it is recommended inspections occur during hours of highest exposure to systems of all external elements.
- 2.4 Client shall ensure that all relevant and appropriate personnel (i.e., technicians, Project maintenance staff, and facilities engineers, if applicable) have been informed prior to, and are available during, each inspection.
- 2.5 WBAC shall have free access to all Systems. Keys, pass cards, or other forms of access shall be provided to WBAC in advance of appearing at the work site. Client, at Client's (or Owner's) sole cost and expense) shall ensure that proper traffic control is in place to protect WBAC employees prior to inspection commencement.
- 2.6 Client shall arrange for parking of WBAC vehicles at no charge to WBAC.
- 2.7 Client shall provide lifting equipment to access systems as required free of charge to WBAC.
- 2.8 Electrical power, water, and waste disposal shall be supplied free of charge to WBAC if applicable.

## 3. No Repairs, Replacement Materials or Monitoring Devices:

- 3.1 This Agreement does not include repairs or provision of replacement materials or monitoring devices of any kind.

3.2 Recommended repairs or inclusion of monitoring devices as determined by WBAC shall be provided to Client for consideration. For Systems supplied by WBAC, recommended repair components shall be submitted for approval to Client, including component and/or system cost alternatives.

Wherefore, the duly authorized representatives of the parties have executed this Agreement to be effective as of the Effective Date.
